



## FOCUS ON 4-H CODE OF CONDUCT For All Participants

**Participants** of Focus on 4-H includes all 4-H members registered at Focus on 4-H, their leaders, parent (or designated supervisor), families and invited friends. All Participants as defined above agree to follow the provincial 4-H rules of conduct while at Focus on 4-H throughout the Village of Thorhild, Thorhild Agriculture Society grounds, Thorhild Community Association grounds, Thorhild County pool, and other recreation facilities, grounds and surrounding parking lots used for the Focus on 4-H program.

### **The 4-H Member agrees to follow:**

- Policy # 1.02 Alberta 4-H Member Code of Conduct Policy
- Not to arrive at Focus on 4-H or at any time during the program, be under the influence or in possession of alcoholic beverages or illegal drugs.
- All overnight areas are considered a quiet zone after midnight
- Any 4-H member, visitors or family member under age of 21 years that stays at an overnight site must be under the direct supervision of their parent, or a designated leader or approved adult supervisor. Any parent /supervisor unable to stay on the grounds overnight to supervise their child must arrange for a designated leader and notify the Focus on 4-H office.
- An approved adult supervisor prior to the 4-H members staying overnight.
- Safe driving practices and to keep to a 15 km per hour speed limit. Please keep in mind the safety of the many children on the grounds.
- Not leaving the program site without the permission of their leaders, parent or designated supervisor.
- Not to be in an area at times or in locations other than those designated by the Focus on 4-H committee
- Not to disrupt any Focus on 4-H event or activity.

### **Focus on 4-H Participant Code of Conduct.**

This Code of Conduct applies to all participants while on property of Village of Thorhild, Thorhild Agriculture Society, Thorhild Community Association, or Thorhild County, in any of the facilities and parking areas being used by Focus on 4-H, and includes overnight sites. Focus on 4-H will be authorized to act on all participants misbehaving outside of registered overnight accommodations. Parents or designated supervisors are responsible for conduct of members on the Focus on 4-H program site and their supervision within overnight accommodations. If a Participant fails to comply with this agreement, he/she may lose the privilege of attending Focus on 4-H events or remaining in the program area. All breaches of conduct will be directed to an Adjudicating Committee for a final decision. All participants agree to comply with the Adjudicating Committee's decision prior to their arrival at Focus on 4-H in Thorhild.
